

Seven Mountains Bill Moerschbacher Scholarship Official Scholarship Application

Eligibility: To be considered for a scholarship grant an applicant must:

1. Be a graduating or just graduated Senior. Applicant must have a minimum commutative grade point average of 2.00 or higher on a 4.00 scale for Grades 9, 10, 11, and the first semester of grade 12. The grade point average must be verified with an official transcript from their school(s).

2. Be nominated by Parent/Grandparent or Legal Guardian who is currently a sanctioned member of the Seven Mountains USBC Bowling Association in good standing. Applicant must designate their legal guardian.

3. Applicant must submit a brief autobiography explaining the candidate's appraisal: personal qualifications, including youth bowling participation and offices held also list participation and offices in activities outside bowling.

4. Applicant must supply three references with at least one from their school. All references must be non-related to the applicant.

5. An applicant may only receive this scholarship grant one time.

Important Directions:

1. On a separate piece of paper, submit a brief (1-2 page) autobiography including a descriptions explaining your appraisal of your personal qualifications, including but not limited to youth bowling participation, outside activities, and offices held in bowling or non bowling activities for grades 9 - 12.

2. *You must have an official copy of your* High School Transcript for grades 9 through 12 (first semester) sent directly to the Seven Mountains Scholarship Committee Secretary.

3. Applications not containing these transcripts will be given back to the applicant so they have an opportunity to fix the application.
